Commitment</b>  _____ Initials	<p><b>Commitment:</b> Because Calvary Christian School makes financial commitments based on enrollment, the following tuition and Facilities Fee commitments are required if withdrawal of the student becomes necessary:</p> <ul style="list-style-type: none"> <li>• Prior to May 14, 2010 the parent/guardian may withdraw from this Enrollment/Financial Agreement without any financial penalty. The parent/guardian must notify the Business Office in writing by May 14, 2010.</li> <li>• If the student is withdrawn after May 14, 2010 and prior to the start of school, the parent/guardian agrees to pay the full Facilities Fee and a tuition commitment amount of \$500 for K-5 and \$1,000 for 1<sup>st</sup> through 12<sup>th</sup> grades. Any amounts paid in tuition at the time of withdrawal will apply towards this amount.</li> <li>• If the student is withdrawn after school starts, the parent/guardian agrees to pay the full Facilities Fee and pro-rated tuition based on the number of days enrolled plus an additional tuition commitment amount of \$500.00 for K5 and \$1000.00 for 1<sup>st</sup> through 12<sup>th</sup> grades.</li> </ul>
<b>4. Other Charges</b>  _____ Initials	<p><b>Other Charges:</b></p> <ul style="list-style-type: none"> <li>• Accounts not paid by the 10<sup>th</sup> of the month will be assessed a late charge of \$25. In the event of a returned bank draft/check or declined credit card due to non-sufficient funds, an additional \$25 charge will be assessed to the account.</li> <li>• Any cost related damage to Calvary property caused by the student beyond reasonable wear and tear as determined by Calvary in its discretion will be paid by the parent/guardian.</li> <li>• Transcripts/withdrawal forms will not be sent to any other educational institution while there is delinquent tuition or fees on the account. Final report cards will be given and diplomas awarded only when tuition is paid in full. Seniors will not be allowed to participate in any ceremonies associated with graduation if there are delinquent fees or tuition on the account.</li> </ul>
